



## Clanking Chains: Assault against the National Entity: Origin, Gen 10; Satanic Assault at Bab-El & God's Multilingual Counterattack, Gen 11

- 4) **National Entity:** A nation is created when a community of people possesses a defined territory under an independent government. When homes and families accumulate in a central geographic location and incorporate under a mutually agreed upon set of establishment norms and standards, legislate enforcement of civil and criminal laws, recognize certain rights possessed by its citizens by virtue of physical birth, and permit the free expression of ideas in the field of Christian theology then a client nation is established.

Nationalism is a divine institution whose origin can be tracked back to Genesis 10. One of Ham's sons (Gen.10:6-8) was Cush who was the father of Nimrod, the human leader of the first satanic attempt to establish a world government and create a global culture under Lucifer's supervision. We see the motivation for this centralization of power in the divine mandate for the survivors of the flood to procreate and populate the entire earth:

**Genesis 9:7** - "And as for you, be fruitful and multiply. Populate the earth abundantly and multiply in it."

This is a universal mandate for the human species to procreate abundantly, bringing potential new witnesses into the courtroom of the appeal trial of Satan. Lucifer, of course, desires to restrict the conversion of these potential witnesses to as few as possible, therefore he inspired the three families of Noah's sons to gather together into a close knit community at what was known then as Babel but which would later become the ancient city of Babylon.

**Genesis 10:6** - And the sons of Ham were Cush, Mizraim, Put, and Canaan.

**v. 8** - Now Cush became the father of Nimrod; he became the mighty one on the earth.

**Genesis 10:10** - The beginning of his kingdom was Babel ... in the land of Shinar.

**Genesis 10:32** - These are the families of the sons of Noah, according to their genealogies, by their nations; and out of these the nations were separated on the earth after the flood [ divine purpose was to separate the three families into separate nations ].

**Genesis 11:1** Now the whole earth used the same language and the same vocabulary.

One of the assets Lucifer had working in his favor was a universal language. This makes it easy to develop a commonly understood propagandistic message through which the masses can be deceived and controlled.

English is the common language of the United States. But under our Constitution, the individual states had the right to maintain "community standards." What was permitted in Boston, New York, or L.A. might not be allowed in Peoria. The amalgamation of the Bill of Rights into the Fourteenth Amendment resulted in creating a common "legal language" within the United States. From that tragic Supreme Court interpretation has been built a diabolical Tower of Bab-El in the USA that enslaves its citizens into the cultural Marxism of the Frankfurt School.

Since the unifying force of a culture begins with its language then a global culture can be more easily developed when everyone speaks the same language. And of course one of the major aspects of any culture is religion.



v. 2 - And it came about as they journeyed east, that they found a plain in the land of Shinar and settled there.

v. 4 - And they said, "Come, let us build for ourselves a city, and a tower whose top will reach into heaven, and let us make for ourselves a name; lest we be scattered abroad over the face of the whole earth."

This is a satanic attempt to isolate the entire world population, made up of the post-flood family of Noah's, into one concentrated geographic location speaking one language and one vocabulary. Under a centralized government held together by one religion, Satan could then manipulate and control the entire world's population. The divine design, however, was separate nations, not united nations. Harry Ironside gives us a synopsis of the development of this first attempt to organize a United Nations:

**Ironside, H. A. *Lectures on the Book of Revelation*. (New York: Loizeaux Brothers, 1932), 287-88:**

We learn that the founder of Bab-el, or Babylon, was Nimrod. He is described as "a mighty hunter before the Lord"—"a hunter of the souls of men," the rabbis said. Going out from the presence of the Lord, he impiously sought to gather a multitude about himself, and, in defiance of the express command of God to spread abroad upon the face of the earth, he persuaded his associates and followers to join together in "building a city and a tower which should reach unto heaven." ... a tower of renown, rising to a great height, to be recognized as a temple or rallying centre for those who did not walk in obedience to the word of the Lord. ... they called their city and tower Bab-El, the gate of God; but it was soon changed by divine judgment into Babel, Confusion.

**Genesis 11:5 -** And the Lord came down to see the city and the tower which the sons of men had built.

v. 6 - And the Lord said, "Behold, they are one people and they all have the same language. And this is what they began to do and now nothing which they purpose to do will be impossible for them.

v. 7 - "Come, let Us go down and there confuse their language, that they might not understand one another's speech."

It is interesting that linguists speculate that human language evolved from one universal language into the polyglot circumstance familiar to recorded history. This subject is mentioned by:

**Bryson, Bill. *The Mother Tongue: English & How It Got That Way*. (New York: William Morrow and Co., 1990), 23-25:**

One of the greatest mysteries of prehistory is how people in widely separated places suddenly and spontaneously developed the capacity for language at roughly the same time. It was as if people carried around in their heads a genetic alarm clock that suddenly went off around the world and led different groups in widely scattered places on every continent to create languages. Even those who were cut off from the twenty or so great language families developed their own quite separate languages.



Or perhaps not. There is increasing evidence to suggest that languages widely dispersed geographically may be more closely related than once thought. Recent studies of cognates—that is, words that have similar spellings and meanings in two or more languages [For example: English *is*, German *ist*, Latin *est*, from Indo-European *esti*.]—have found possible links between some unlikely language partners. Some cognates may even be universal. As Merrit Ruhlen noted in *Natural History* magazine [March 1987]: “The significant number of such global cognates leads some linguists to conclude that all the world’s languages ultimately belong to a single language family.”

Correct! This is clearly stated in Genesis 11:1 and 11:6. The Lord states the fact that through a common language Nimrod gathered the scattered nations into a centralized location so that under the power of a central government and the tyranny of a world religion he could propagandize them into becoming witnesses for the defense in the appeal trial of Satan. Nimrod was a “hunter of souls” for the Satanic Academy of Cosmic Didactics.

Bryson goes on to reveal some very critical information that not only amplifies the power of language in controlling populations but also the reason children are the obvious target of linguistic manipulation.

#### **Bryson, *The Mother Tongue*, 25-26:**

Much of what we know ... about the roots of language comes from watching children learn to speak. For a long time it was believed that language was simply learned. The presumption was that our minds at birth were blank slates onto which the rules of quirks of our native languages were written. But then other authorities, ... began to challenge this view, arguing that some structural facets of language—the *ground rules* of speech—must be innate.

In our study of the *Theology of Neurology* we found this to be documented by neuroscience. An instructive quote from that study reminds us of this fact:

**Thompson, Richard F. *The Brain: A Neuroscience Primer*. 2d ed. (New York: W, H. Freeman and Co., 1993), 391:**

All languages, from English to obscure dialects, have the same degree of complexity and similar general properties. It is as though humans came into the world equipped with a well-elaborated, complex, and biologically determined language system. In short, it would seem that we may have speech and language centers in the brain that are in some ways predetermined or preprogrammed.

Thompson begins his chapter on language by writing, “Language is the one species-typical behavior that sets humans completely apart from all other animals.”

Why is this? Because the human race is the only animal to whom God seeks to communicate. He has caused His thoughts to be written in Scripture which in itself requires the existence of language.

God, being the inventor of language and the creator of the human brain, so programmed the human brain that He could communicate His message to man with a perfect vocabulary, utilizing perfect syntax, and thus revealing to us perfect content.
