

**David's Heir: Retroactive Positional Truth & Characteristics of the Sin Nature: Their Power Broken by the Substitutionary Spiritual Death of Christ; Holy Spirit Provides Power to Battle the Dark Side; Human Good Is Man's Efforts to Do Good Apart from Grace; Human Good Intensified Results in Evil; Saul Was Jealous of David's Popularity & Plotted to Kill Him; Successes Would Have Canceled the Davidic Line to Jesus**

27. The sin nature was crucified by Christ. It was crucified in us when we expressed faith in Him for salvation. We refer to this as retroactive positional truth: we go back to the cross to appropriate the work of Christ with regard to our sin nature.
28. His spiritual death resulted in the judgment of all the sins of the human race and breaks the power of the sin nature as ruler of human life.
29. The removal of the power of the sin nature makes it possible for human free will to successfully wage war against the satanic strategies of human good and evil which are the strengths of the sin nature.
30. Human good refers to anything produced by man apart from the provisions of grace. Anything God provides in grace may be used to produce divine good.
31. When human good is intensified it results in evil. For example: health insurance is an aspect of free enterprise whereby under contract the insurance company guarantees to underwrite the cost of one's medical expenses.
32. The capital that enables the contract to be honored is provided by premiums from clients. This revenue is retained in a pool from which is drawn the necessary funds to cover individual claims.
33. To protect the integrity of each person's contract, the insurance company must additionally rate preexisting conditions; not to do so would endanger its ability to provide coverage for all of its clients.
34. A human-good idea is when the government decides to take on these responsibilities for every person in the country without any regard for preexisting conditions or individual ability to pay the premiums.
35. Implementation of such a scheme is the intensification of a human-good idea into evil which will result in decreased and inferior health coverage, a shortage of competent medical practitioners, and the ultimate depletion of the monetary pool from which claims are to be paid.
36. The upside for the Dark Side is that the system will enhance its control of the entire population with the power to selectively eliminate those whose worldview is in opposition to its nefarious agenda.
37. Principle: The Affordable Care Act is a rhetorical veil which conceals while it advances a hidden agenda. It has little to do with caring for anyone's health, but a lot to do in controlling everyone's life.
38. Under the correct rationale that "the people" pay for your medical bills, the government, being "the people's" parent and guardian, will ultimately dictate what you can eat, where you can go, what you can do, and in not-so-subtle ways what you can think and say.
39. To make the issue clear, enforcement will be carried out by the Internal Revenue Service, the ultimate hammer that tattoos everyone at birth with a tracking number.
40. Therefore we can see from this example that even though sin has been judged, the sin nature's area of strength—human good—has been allowed by God to continue as Lucifer's game plan for the angelic conflict.

41. The only defense against the insidious evils that it produces is the inculcation, retention, enlargement, and application of Bible doctrine in the soul.
42. Historical downtrends can be tracked by cataloging forays into human good. As they become broadly accepted, the resultant evil destroys the moral fiber of the people. Such a population will be destroyed from within before it falls to a predator nation.
43. Saul allowed his army to continue in a forty-day stalemate with the Philistine army at Elah because he was afraid to take the initiative.
44. When David consulted Saul for permission to challenge Goliath in a Battle of Champions, Saul moved into human good by offering him his panoply. (2 Samuel 17:38)
45. If David were victorious then Saul could have taken some credit at the press conference: "I killed Goliath." If David lost it would be because he was just a boy who took on more panoply than he could carry.
46. David's victory, sans panoply, resulted in public adulation for which Saul could take no credit. The ladies' paeans celebrating David's military prowess over Saul's initiated the king's indulgence in a multiplicity of sins designed to remove David from the scene.
47. The entire saga involving David and Saul demonstrates and illustrates the contest between doctrine and darkness.
48. David remained loyal to the Word and trusted in God's provision and protection.
49. Saul entered into reversionism where the failure of human good led to a spree of sin-inspired actions designed to assassinate David.
50. These sins were encouraged by demon influence. Lucifer dispatched a special-forces guerrilla to infiltrate the king's thinking.
51. The effort was designed to prevent David as king elect from ever reaching the throne of Israel and thus sever the Messiah's royal line.
